on april 15 2002 air china flight 129 a boeing 767 200er operated by air china en route from beijing china to busan korea crashed on mt dotdae near gimhae airport busan of the 166 persons on board 37 persons survived the crash while 129 occupants were killed the korean aviation accident investigation board kaaib determined that the probable cause of the crash was pilot error due to poor crew resource management and lost situational awareness during the circling approach of the runway the chinese investigation team pointed out that the korean atc was not fully licensed and mistakenly directed the airliner to descend to a wrong altitude and that the airport did not inform the crew of the weather conditions at the time a contributing factor was that the airline made all announcements in chinese and english while most passengers were korean

during takeoff from runway 02 at tamanrasset aguenar aerodrome in southern algeria on thursday 6 march 2003 the left engine of a boeing 737 200 from air algerie suffered a contained burst the airplane swung to the left the captain took over the controls the airplane lost speed progressively stalled and crashed with the landing gear still extended about one thousand six hundred and forty five meters from the takeoff point to the left of the runway extended centerline the crew of six and 96 of the 97 passengers were killed in the accident the accident was caused by the loss of an engine during a critical phase of flight the non retraction of the landing gear after the engine failure and the captain the pnf taking over control of the airplane before having clearly identified the problem

on 25 december 2003 union des transport a riens de guine e flight gih 141 a boeing 727 223 on a flight from conakry guinea to kufra libya beirut lebanon and dubai united arab emirates stopped over at cotonou republic of benin during takeoff the overloaded airplane was not able to climb properly and struck an airport building on the extended runway centerline and crashed onto the beach and ended up in the ocean killing 151 of the 163 people on board the cause of the accident was the difficulty for the flight crew to rotate with an overloaded airplane with an unknown center of gravity this in combination with the facts that the operator of the airline lacked any competence regarding organization and regulatory documentation which made it impossible to correctly load and check the loading of the airplane and the inadequacy of the supervision exercised by the guinean civil aviation authorities in the context of safety oversight

at the height of the watergate scandal delta flight 723 crashed into a fog shrouded seawall at the end of runway 4r at logan airport in boston while this incident and watergate seemed unrelated at first president richard nixon and his subordinates actions during watergate interfered with the ability of the national transportation safety board to properly investigate the crash it wasn t until three court cases a federal investigation congressional hearings as well as a state investigation when the true cause of the accident was exposed ten years later this is also the story of air force sergeant leopold chouinard and his incredible fight for survival chouinard survived the initial impact of the crash only to suffer third and fourth degree burns on the majority of his body doctors fought against incredible odds to try and save chouinard s life for 134 days leo chouinard defied all expectations as his doctors and nurses applied the latest advancements in burn treatments to save him from a non survivable accident they nearly succeeded through interviews with chouinard s family his physicians and the ntsb s investigation comes a story of corruption determination and vindication as well as the answer to what really caused that crash at logan airport

on october 19 2004 about 1937 central daylight time corporate airlines doing business as american connection flight 5966 a bae systems bae j3201 n875jx struck trees on final approach and crashed short of runway 36 at the kirksville regional airport irk kirksville missouri the flight was operating under the provisions of 14 code of federal regulations part 121 as a scheduled passenger flight from lambert st louis international airport in st louis missouri to irk the captain first officer and 11 of the 13 passengers were fatally injured and 2 passengers received serious injuries the airplane was destroyed by impact and a post impact fire night instrument meteorological conditions imc prevailed at the time of the accident and the flight operated on an instrument flight rules flight plan the national transportation safety board determines that the probable cause of the accident was the pilots failure to follow established procedures and properly conduct a nonprecision instrument approach at night in imc including their descent below the minimum descent altitude mda before required visual cues were available which continued unmoderated until the airplane struck the trees and their failure to adhere to the established division of duties between the flying and nonflying monitoring pilot contributing to the accident was the pilots failure to make standard callouts and the current federal aviation regulations that allow pilots to descend below the mda into a region in which safe obstacle clearance is not assured based upon seeing only the airport approach lights the pilots unprofessional behavior during the flight and their fatigue likely contributed to their degraded performance the safety issues in this report focus on operational and human factors issues including the pilots professionalism and sterile cockpit procedures nonprecision instrument approach procedures flight and duty time regulations fatigue and flight data image recorder requirements
